

Real's Youth Volleyball Camps

For Boys & Girls Ages 8-14 Years Old

General Skills Camp: Participants will learn the fundamentals of volleyball that include the forearm and overhead pass, set, spike and serve. They will improve those skills through repetitive practice and individualized instruction and feedback. Offensive and defensive formations and strategies will also be taught, including serve reception, blocking and digging. All skills will be showcased in team drills, scrimmages and tournament play.

Setter/Hitters Camp: The Setter/Hitter Camp is for athletes who already have established themselves as a setter or hitter and want to improve these skills. This session focuses specifically on improving hitting or setting techniques for improved execution during game situations. Players enrolling in this camp should be ready for intermediate/advanced skills training.

Serve/Pass/Defense Camp: This skill-specific camp focuses on passing and defensive techniques, including forearm passing, overhead passing, digging and reading the hitters. Serving will also be an emphasis as a defensive tool.
