Surveys

Annually the Burbank Unified School District distributes a Climate Survey to employees, parents, and secondary students. The survey in the past was available in early fall. This year a committee will be reviewing and revising components of the survey and planned distribution to stakeholders is in spring of 2020.

Informal surveys of the staff were verbally conducted during our site's pre-service days in August. Teachers stated that they would like professional development especially in the area math and STEM.

Classroom Observations

This section provides a description of types and frequency of classroom observations conducted during the school-year and a summary of findings.

The principal visits classrooms regularly to observe teaching strategies. Staff is aware of ongoing visits and that the principal is looking for engagement strategies, direct instruction, and independent practice. The principal spends about 3-4 hours per week in classroom visits and provides specific feedback to the teachers both verbally and in writing. Also monthly English Language Learning walks are conducted by the principal to see use of EL strategies. Discussion of findings are frequently reviewed at faculty meetings as well as sharing best practices. The principal also conducts 2 formal observations per teachers per contract and Ed Code.

Analysis of Current Instructional Program

The following statements are derived from the Elementary and Secondary Education Act (ESEA) of 1965 and Essential Program Components (EPCs). Standards, Assessment, and Accountability

Use of state and local assessments to modify instruction and improve student achievement (ESEA)

Last year Edison took the CAASPP tests. Teachers will also be using district benchmark tests, writing prompts and the middle of the year/end of the year math assessment from the district adopted series, Houghton Mifflin Go Math and Benchmark Advanced to guide instruction meeting students' specific needs in Kindergarten through 5th grade. The following were assessments used to measure student achievement this year:

End of the year SRI scores (grades 2-5)

End of the year Oral Reading Fluency (grades 1-5)

End of the year Grade Equivalent (grade 1-5)

End of the year Kindergarten Assessments

Use of data to monitor student progress on curriculum-embedded assessments and modify instruction (EPC)

In addition to local benchmark assessments, primary students take curriculum-based assessments in their Power Hour groups to determine if they are making progress towards proficiency. At each trimester, teachers review the results of these assessments and the trimester benchmarks and students are regrouped as needed. The results are analyzed through AERIES.net and teacher review the concepts that were not mastered.

Analysis of the assessment data shows the success of the Power Hour intervention model for closing the achievement gap. All students in first through fifth grade are homogeneously grouped for 30 minutes a day to provide them with targeted instruction in their area of need in phonics, vocabulary development, reading fluency, comprehension or math. Students with learning disabilities and English Learners are included in the Power Hour rotation.

Staffing and Professional Development

Status of meeting requirements for highly qualified staff (ESEA)

All of the Edison teachers meet the ESEA/ESSA criteria for highly qualified staff by meeting their State certification requirements. Classified staff also meet ESEA/ESSA requirements through district level hiring ptractices.

Sufficiency of credentialed teachers and teacher professional development (e.g., access to instructional materials training on SBE-adopted instructional materials) (EPC)

Edison meets the sufficiency requirements of credentialed teachers. Teachers participate in district-wide professional development related to California State Standards, schoolwide staff development related to the California State Standards, and the development and implementation of successful instructional strategies.

Alignment of staff development to content standards, assessed student performance, and professional needs (ESEA)

Staff development is aligned with California State Standards and Frameworks and is based on the area of needs as identified on the district interim and site assessments results. This year our focus will continue with the math series of Houghton Mifflin Go Math and the Math Standards. Edison will also have a focus for 4th and 5th grade in STEM and a continued focus on Project GLAD for our English Learners.

Ongoing instructional assistance and support for teachers (e.g., use of content experts and instructional coaches) (EPC)

Edison teachers receive professional development in understanding California State Standards at the district and site level. Improving student engagement remains a focus and continued opportunities for training in student engagement strategies are offered during the school year. In addition, effective instructional strategies are researched, discussed and shared during faculty and grade level meetings. Ongoing assistance is provided by the curriculum specialist, by colleagues with strengths in areas of need and by the principal. Teachers meet by grade level with the curriculum specialist weekly to review data and plan curriculum. Our EL specialist will continue to work with staff in the area of EL instruction strategies, such as Project GLAD.

Teacher collaboration by grade level (kindergarten through grade eight [K–8]) and department (grades nine through twelve) (EPC)

Students are released early on Tuesdays to allow teachers time to meet as a grade level once a month. During this time, teachers meet collaboratively to plan lessons. Each trimester, we study student progress and review the RTI groups in which students are placed according to their instructional needs in the area of ELA. We discuss target students and ways in which we can modify our instructional program and pacing to ensure all standards are being taught in a timely way.

Teaching and Learning

Alignment of curriculum, instruction, and materials to content and performance standards (ESEA) The curriculum, instructional program and materials are all aligned with the State of California's content standards for each required subject matter, at all grade levels. District developed common assessments are developed and utilized to ensure that teachers are providing curriculum and instructional programs that are paced in a manner such that all students have the opportunity to master the content standards by the end of the year. Student progress is monitored by the collections of benchmark assessment data, as well as proficiency rates, determined by ESEA/ESSA based performance standards.

Adherence to recommended instructional minutes for reading/language arts and mathematics (K–8) (EPC)

All students at Edison Elementary School must be provided the opportunity to meet State content standards at grade level. All instructional minutes are monitored by BUSD and have been found to exceed State requirements.

Lesson pacing schedule (K–8) and master schedule flexibility for sufficient numbers of intervention courses (EPC)

Teachers participate in a regular review of the California State Standards and are expected to align the pace of their instruction through backwards mapping. Teachers have been provided a lesson pacing schedule for E/LA Math this year. All grades have been provided with math materials that have been aligned with California State Standards.

Availability of standards-based instructional materials appropriate to all student groups (ESEA) All students have standards-based instructional materials appropriate to all grade levels.

Use of SBE-adopted and standards-aligned instructional materials, including intervention materials, and for high school students, access to standards-aligned core courses (EPC)

Every student has access to District approved, State Board of Education(SBE) adopted instructional materials in every subject area, including those used in intervention sessions.

Opportunity and Equal Educational Access

Services provided by the regular program that enable underperforming students to meet standards (ESEA)

Edison's Power Hour/Rtl program:

The emphasis of a Response to Intervention (RtI) is to prevent delays with the students who are struggling academically. Our school provides Tier 2 intervention to all students who are not performing at grade level. This means that five days a week, students are placed in small groups and are provided targeted instruction in English / language arts. In order to begin implementation of RtI staff use criterion-based and/or norm-referenced assessments to determine which students are or are not meeting the expected grade level benchmarks. In order to best serve the needs of our students we have hired 4 credentialed teachers who support our grade level RtI rotations. The targeted skills and instructional materials used for RtI vary from phonics to reading comprehension and writing strategies, depending on the need of the grade level.

Evidence-based educational practices to raise student achievement

Kagan Cooperative Learning Structures are a research based engagement strategy that we use at our school in grades K-5. Systematic ELD is a program that provides all of our English Learners with 30 minutes per day of dedicated instructional time in the area of English Language Development. GLAD (Guided Language Acquisition Design) is a set of strategies which meet the cognitive and linguistic needs of ELD students. Two teachers are being trained this year and the ELD specialist will be training the staff on some of the most effective strategies. Power Hour, our Rtl program is a five days a week program where students receive differentiated Language Arts instruction at their grade level, grades 1-5.

Math intervention for students in grades K-5 is also provided.

Parental Engagement

Resources available from family, school, district, and community to assist under-achieving students (ESEA)

School wide assessment results were reviewed and interpreted at SSC by October 2019. The instructional leadership team, grade level teams and ELAC have also provided us with an in-depth review of the data. The committees were led in discussion by the principal, curriculum specialist, or teachers.

Involvement of parents, community representatives, classroom teachers, other school personnel, and students in secondary schools, in the planning, implementation, and evaluation of ConApp programs (5 California Code of Regulations 3932)

At Edison Elementary School, parents are offered a wide variety of involvement opportunities at our school. In the fall, the principal shared information on the California State Standards and on the newly adopted math series with stakeholder groups, such as the PTA, Boosters Club, English Learner Advisory Committee, and the School Site Council. Staff has made a conscious effort to improve the level of contact and the involvement of all parents in classrooms. Further, Edison is one of the few BUSD elementary schools to publish a weekly parent newsletter that is sent to all parents.

Parent representatives involved in Edison's School Site Council continually monitor the effective implementation of the Single Plan for Student Achievement where data information will be shared in an ongoing fashion. Additionally, parents involved in the English Learner Advisory Committee are provided the opportunity to give their input regarding the achievement of English Learners. School achievement data is made available to all parents in writing by sending home information in the bimonthly newsletter. The Kindergarten Orientation for new K parents gives parents of brand new students an early insight into elementary education. At our school, we host two rounds of parent teacher conferences each year. At these meetings, teachers have the opportunity to connect with every parent, as they provide detailed information about each child's performance.

Funding

Services provided by categorical funds that enable underperforming students to meet standards (ESEA)

Federal Title III funds support English Learners who are below grade level in Mathematics and in the area of literacy/reading.

Fiscal support (EPC)

Edison Elementary School will receive \$3,648 in Title III EL (LEP) funds this school year. Additionally, Edison will receive \$264 Title III Immigrant funds.

Each of these meetings was to gather input from stakeholders and explain the process and purpose of the SPSA.

 - iii. provide an enriched and accelerated curriculum, which may include programs, activities, and courses necessary to provide a well-rounded education.
 - c. Address the needs of all children in the school, but particularly the needs of those at risk of not meeting the challenging State academic standards, so that all students demonstrate at least proficiency on the State's academic standards through activities which may include:
 - i. strategies to improve students' skills outside the academic subject areas;
 - ii. preparation for and awareness of opportunities for postsecondary education and the workforce;
 - iii. implementation of a schoolwide tiered model to prevent and address problem behavior;
 - iv. professional development and other activities for teachers, paraprofessionals, and other school personnel to improve instruction and use of data; and
 - v. strategies for assisting preschool children in the transition from early childhood education programs to local elementary school programs.
- C. Proposed expenditures, based on the projected resource allocation from the governing board or body of the local educational agency (may include funds allocated via the ConApp, federal funds for CSI, any other state or local funds allocated to the school), to address the findings of the needs assessment consistent with the state priorities, including identifying resource inequities, which may include a review of the LEAs budgeting, it's LCAP, and school-level budgeting, if applicable (described in Proposed Expenditures and Budget Summary). Employees of the schoolwide program may be deemed funded by a single cost objective.

 - Annually evaluate the implementation of, and results achieved by, the schoolwide program, using data from the State's annual assessments and other indicators of academic achievement;
 - 2. Determine whether the schoolwide program has been effective in increasing the achievement of students in meeting the State's academic standards, particularly for those students who had been furthest from achieving the standards; and
 - 3. Revise the plan, as necessary, based on the results of the evaluation, to ensure continuous improvement of students in the schoolwide program.

- E. A description of how the school will ensure parental involvement in the planning, review, and improvement of the schoolwide program plan (described in Stakeholder Involvement and/or Strategies/Activities).
- F. A description of the activities the school will include to ensure that students who experience difficulty attaining proficient or advanced levels of academic achievement standards will be provided with effective, timely additional support, including measures to
 - 1. Ensure that those students' difficulties are identified on a timely basis; and
 - 2. Provide sufficient information on which to base effective assistance to those students.
- G. For an elementary school, a description of how the school will assist preschool students in the successful transition from early childhood programs to the school.
- H. A description of how the school will use resources to carry out these components (described in the Proposed Expenditures for Strategies/Activities).
- I. A description of any other activities and objectives as established by the SSC (described in the Strategies/Activities).

The CSI plan shall:

- 1. Be informed by all state indicators, including student performance against state-determined long-term goals (Goal, Identified Need, Expected Annual Measurable Outcomes, Annual Review and Update, as applicable);

- 4. Identify resource inequities, which may include a review of LEA- and school-level budgeting, to be addressed through implementation of the CSI plan (Goal, Identified Need, Expected Annual Measurable Outcomes, Planned Strategies/Activities; and Annual Review and Update, as applicable).

Targeted Support and Improvement

In partnership with stakeholders (including principals and other school leaders, teachers, and parents) the school shall develop and implement a school-level TSI plan to improve student outcomes for each subgroup of students that was the subject of identification (Stakeholder Involvement).

The TSI plan shall:

- Be informed by all state indicators, including student performance against state-determined long-term goals (Goal, Identified Need, Expected Annual Measurable Outcomes, Annual Review and Update, as applicable); and
- Include evidence-based interventions (Planned Strategies/Activities, Annual Review and Update, as applicable). (For resources related to evidence-based interventions, see the U.S. Department of Education's "Using Evidence to Strengthen Education Investments" https://www2.ed.gov/policy/elsec/leg/essa/guidanceuseseinvestment.pdf.)

Additional Targeted Support and Improvement

A school identified for ATSI shall:

1. Identify resource inequities, which may include a review of LEA- and school-level budgeting, which will be addressed through implementation of its TSI plan (Goal, Identified Need, Expected Annual Measurable Outcomes, Planned Strategies/Activities, and Annual Review and Update, as applicable).

Authority Cited: Sections 1003(e)(1)(B), 1003(i), 1111(c)(4)(B), and 1111(d)(2)(c) of the ESSA.

Single School Districts and Charter Schools Identified for School Improvement

Single school districts (SSDs) or charter schools that are identified for CSI, TSI, or ATSI, shall develop a SPSA that addresses the applicable requirements above as a condition of receiving funds (EC Section 64001[a] as amended by Assembly Bill [AB] 716, effective January 1, 2019).

However, a SSD or a charter school may streamline the process by combining state and federal requirements into one document which may include the local control and accountability plan (LCAP) and all federal planning requirements, provided that the combined plan is able to demonstrate that the legal requirements for each of the plans is met (EC Section 52062[a] as amended by AB 716, effective January 1, 2019).

Planning requirements for single school districts and charter schools choosing to exercise this option are available in the LCAP Instructions.
