A Burbank Unified School District bond proposition, Measure BUSD-S ballot for \$110M was on the March 5, 2013, ballot for voters in the Burbank Unified School District in Los Angeles County, where it was approved.

The goal of this bond is to improve the quality and safety of Burbank school facilities, to upgrade classrooms, computers and technology, to replace aging portable classrooms, electrical systems, plumbing and sewer lines, roofs and play areas, to improve student safety and security including upgraded fire protection, increase energy efficiency and to provide accessibility for students with disabilities.

An accountability safeguard for Measure S is an independent citizens' oversight committee that was established to ensure bond proceeds are expended only for the school facilities projects

listed in the Bond Project List.

The citizens' oversight committee consists of at least seven members and includes members who are active in organizations representing the business community located within the District. A member who is active in a senior citizens' organization. A member active in a bona fide taxpayers' organization. A member that is a parent or guardian of a child enrolled in the District as well as a member that is both a parent or guardian of a child enrolled in the District and active in a parent-teacher organization. No employee or official of the District and no vendor, contractor or consultant of the District can be appointed to the citizens' oversight committee.

Another accountability safeguard is annual, independent, financial and performance audits that are conducted in accordance with government auditing standards that are issued by the Comptroller General of the United States.

These measures along with the continued support, commitment and truly remarkable community engagement have made for a successful and productive 4th year of Bond project advancements.

2017-2018 Planned Projects In 2017 several large infrastructure bond projects that started in 2016 were completed. These projects included; energy management, fire alarm, clocks, public address systems, heating, ventilating and air conditioning upgrades at nine (9) sites. Portable classroom replacements are complete or near completion at Robert Louis Stevenson, Bret Harte and Thomas Jefferson Elementary Schools. Horace Mann

Children's Center benefitted from an extensive modernization that was started in 2016 and completed this year. Perimeter fencing projects were completed at Stevenson and Jefferson Elementary Schools. Three children's play structures were completed this year at Roosevelt, Stevenson and Emer-Elementary Schools. Utilizing Deferred Maintenance funds, the District completed painting projects at Luther Burbank and Muir

Middle Schools. Burbank High School LED lighting retrofit was completed in 2018 as well.

The District's completed technology projects include Voice over Internet Protocol (VoIP) at eight (8) sites. Network infrastructure upgrades at eight (8) sites. Upgrades and 21st Century classroom upgrades at seven (7) sites.



2017 - 2018 School Year Completed & Near Completed Projects

New modular classroom buildings were installed at Jefferson, Harte and Stevenson Elementary Schools. Stevenson ES are already occupying their buildings. Jefferson and Harte will occupy in the 2018-2019 school year. The Stevenson ES modular project consists of ten (10) classrooms and four (4) fully refurbished portable classrooms.




The Thomas Jefferson ES modular project consists of nine (9) classrooms which will open August 2018.



The Bret Harte ES modular project consists of a two-story building containing twelve classrooms and a single-story building containing four classrooms which will open August 2018.

An extensive modernization of Mann was completed. This work included fire sprinklers, fire alarm, public address, energy management system (EMS), HVAC, lighting, ADA, flooring, resilient flooring, casework, restroom remodel, and painting. The technology effort consisted of adding network infrastructure, site computers, and the 21st Century Classroom modernization features.


2018-2019 McKinley Elementary School Removal and Replacement of Portable/Modular Classrooms

The District will remove old portable classroom buildings at William McKinley elementary school. The new replacement classrooms will include many upgrades compared to the old classrooms. These upgrades include built in teaching walls, better quality and more efficient LED lighting. Classrooms will be modernized with 21st Century teaching technology and improved wireless equipment.
